OFFICE ORDER

In consequent to the closure of NATMO Printing Press vide Copy No. 4 of 8 dated 20.06.2018 from Cabinet Secretariat, Rashtrapati Bhawan and Office of the Secretary, DST Dy. No. L-R-47/34 dated 21-06-2018 and in continuation to NATMO Notice No. 59-1/2017-Estt/1619 dated 27-07-2018 regarding Closing of NATMO Press [vide], it is declared that NATMO Press is closed with effect from 21/06/2018. Accordingly, the posts related to NATMO Press & Camera Unit is also be treated as abolished with effect from 21/06/2018. However, the existing staff members, will be re-deployed/ re-allocated in other posts as per guidance of the Government.
